## Client Investigation Agreement and Release Form

For the purpose of this agreement, the term client(s) is defined as property owner, occupant, renter, agent, or representative of the property being investigated.

1. I (client as identified above and by signature below) hereby grant permission for Global United Paranormal Foundation (GUPF) to perform a paranormal investigation on my property indicated above and to gather, review and analyze evidence collected during that investigation, including witness statements, audio and video recordings, photographs and other scientific readings.

2. CONFIDENTIALITY – Client(s) gives permission to allow GUPF to obtain case details from and gain advice from family, friends, other paranormal research teams or other involved parties providing personal information about the client(s) is removed prior to doing so.

3. CLIENT RESPONSIBILITIES -- Client understands and agrees that the following client guidelines will be adhered to:

3.1. Client will at no time knowingly falsify any claims of paranormal activity before, during or after the investigation by GUPF.

3.2. The client(s) will make no false or misleading statements about the GUPF team and/or their paranormal investigation of the investigation site.

3.3. No media will be invited to witness, film or otherwise document the investigation without the express permission of GUPF.

3.4. In order to have an uninterrupted investigation, no persons other than the clients will be on site during the investigation. Client understands that GUPF may request that any children or pets residing at the investigation location be removed during the investigation and agree to comply, to the best of their ability, with any such request. Exceptions are made on a case-by-case basis for clients wanting someone present morale support.

3.5. Client understands that any noise producing appliances or equipment at the location may be requested to be turned off during the investigation. The client(s) will comply with these requests unless doing so jeopardizes the health or safety of those in the location.

3.6. There will be no smoking, alcohol drinking or illegal drug use in the investigation site during the investigation except in designated areas. Client understands that GUPF may suspend the investigation at any time if any person present at the investigation site is found to be using cigarettes, alcohol or illegal drugs and disrupting the investigation.

3.7. Client agrees that any weapons stored at the location will be secured and at no time will they be available to any person at the investigation site including clients, GUPF team members or other interested parties unless prior agreed upon.

4. EVIDENCE -- GUPF investigations are performed strictly to document, analyze and report evidence of paranormal activity.

4.1. Evidence will be collected using digital and analog audio and video recording devices, digital and 35mm cameras, EMF detectors, temperature monitoring equipment and any other equipment GUPF deems necessary. All data collected will be combined with other case files in a database for review and analysis. This data includes witness demographics, general site information, reported activity details and evidence collected. Compiling this data does not violate the confidentiality terms outlined in paragraph 2.

4.2. Client understands that GUPF will provide them with a written report including an SD card containing copies of only those photographs, video or audio clips which contain documented evidence of the paranormal and that GUPF will make the determination as to what constitutes evidence. Client further understands that all other photographs, video or audio recordings remain the sole property of GUPF and its members.

4.3. Client agrees not to release, publish or make profit from copies of documented evidence provided by GUPF and obtained during the investigation, such as photographs, audio or video clips, case reports, investigator field notes, etc. without the express permission of GUPF.

5. SPIRIT REMOVAL -- Upon client request, GUPF may offer guidance regarding spirit removal. GUPF does not guarantee the results of such actions taken by the client or other interested parties to remove spirits.

6. TERMINATION -- GUPF may terminate the investigation at any time at its sole discretion if any of the terms of this agreement are not followed. Additionally, The client(s) may terminate the investigation at any point during the course of the investigation process without stating a cause for such action. Client understands and agrees that if the investigation is terminated at their request GUPF may not provide client copies of any evidence or case notes and the relationship with GUPF will end.

7. RELEASE OF CONFIDENTIALITY -- I agree to allow GUPF held harmless and give permission for GUPF to publicize any and all data collected during their investigation of my property or location I am responsible for. This data may include video recordings, photographic imagery and audio recordings. I also agree to release atmospheric measurements that may have been collected during their investigation. This can include but not limited to atmospheric pressure, humidity, temperature, ion readings, emf readings, or radiation readings.

I DO agree to paragraph 7. And, I agree to fully allow GUPF to disclose any and all information including identity and data collected information as they deem necessary.

I NO agree to paragraph 7, but DO NOT agree to have my name or location made public. And, I elect to allow data and evidence be shared by GUPF with stipulating my personal identifying information be held in complete confidentiality.

I DO NOT agree with paragraph 7. And, I elect to have GUPF keep all data and personal identifying information collected during the investigation held completely confidential.
